## Driving Record Check Authorization Judson Child Safe Mentorship Program

I, \_\_\_\_\_, hereby give Judson Center Child Safe and/or its insurance agent(s) permission to perform any required checks of my driving record as required for purposes of verifying compliance of the underwriting criteria established by our insurance carriers.

**I understand that a mentor whose duties require the operation of a vehicle shall be required to have and maintain a valid Michigan driver's license.** Upon acceptance into the Mentorship Program, driving records are checked through the Secretary of State. Notification of ongoing traffic violations is sent to the Agency by the Secretary of State. I understand that it is my obligation to inform Judson Center Child Safe immediately should any changes occur to my driving record, including tickets (except parking) and any accidents that were my fault in whole or in part. I understand that failure to promptly disclose this information may result in my being removed from the Mentorship Program.

### Utilizing Mentor's Vehicle

Mentors are required to use their own personal vehicles for participation in the Mentorship Program. Auto insurance coverage for Mentor owned or leased vehicles shall be adequate to cover not only damage to the vehicle and other property damage in the event of an accident, but also injuries sustained by individuals, including Mentees, as a result of the accident. I understand that it is my responsibility to maintain current and valid insurance coverage as stated above. I further understand that failure to maintain proper insurance coverage on any personal vehicle used in the course of the mentorship will result in my being temporarily ineligible to participate in the Mentorship Program until such time as I present proof of current and valid auto insurance coverage.

## **Underwriting Criteria for Judson Center Drivers**

*(Mentors who drive personal vehicles in which Mentees are likely to be passengers.)*

1. Drivers must have a valid driver's license.
2. A driver should have at least two years driving experience, and be at least 18 years of age.
3. Drivers should have no more than:
  - a. Three (3) moving violations (personal and/or business usage) in the past three (3) years.
  - b. Two (2) accidents in the past three years.
    - i. Proof of not-at-fault status for accidents must be submitted to rescind this requirement.
  - c. Or a combination of more than a total of four (4) of "a" and "b" above.
4. No major violations in the past four years, such as:
  - a. Reckless driving
  - b. Driving Under the Influence (DUI)
  - c. Vehicular Manslaughter
  - d. Exhibition of speed
  - e. Leaving the Scene of an Accident, etc.
5. Drivers should not have a violation for driving on a suspended/revoked license in the past four (4) years.
6. In the past three (3) years, drivers should have no more than a combination of four (4) of the following violations:
  - a. Failure to Appear (FTA)
  - b. Unlicensed Driver
  - c. No Proof of Insurance

The insurance underwriter reserves the right to exclude drivers under their own discretion. Exception requests need to be made in writing to the appropriate underwriter.
